- B. Customer Information: All material is shipped with a delivery ticket. A priced invoice will be mailed to the appropriate address. Accounts are summarized on the last day of the month and statements are mailed on the first (1<sup>st</sup>) with payment in full due by the tenth (10<sup>th</sup>).
- C. The applicant agrees, as evidenced by the signature found below, to pay for all purchases according to the terms and conditions as set out in the Agreement and in the invoices, inclusive of any subsequent revisions to the terms and conditions, issued by WAKE STONE CORPORATION, and said terms shall become part of any sales agreement, purchase orders or other documents unless specifically approved in writing by WAKE STONE CORPORATION.
- D. The applicant further agrees to pay all invoices within 30 days from date of purchase. In the event it becomes necessary to place an account with an outside collection agency, or attorney, for collection, suit or other legal action, the applicant agrees to pay all cost of such proceedings, including reasonable attorneys fees.
